A NOTE FROM HOLLY BOREL

Spindletop Center continued its strong commitment to our communities in Fiscal Year 2023, serving more than 16,000+ vulnerable Southeast Texans. Being at the forefront of information technology is vital to our ability to provide emergent, affordable healthcare to our clients and community. Continuing to advance our health care offerings, Spindletop Center successfully implemented a new electronic health record, Netsmart MyAvatar, which serves as the medical record for clients in all programs (ECI, MH, SUD, IDD). Our Go-Live on March 1, 2023 was the culmination of almost a year of planning and project team activities.

The Center had many successes to celebrate in FY2023 including completing construction and the grand opening of Spindletop Center's newest location in Silsbee, TX in June. 1,457 individuals were served in Hardin County during our most recent fiscal year and the new clinic aims to improve access to a full array of behavioral health services for individuals in Jasper and Hardin counties. The new 14,500 square foot Spindletop Center facility in Silsbee offers outpatient mental health services for children and adults, Early Childhood Intervention (ECI) services, Substance Use Disorder (SUD) services, as well as services for individuals with intellectual and developmental disabilities (IDD).

Renovations in the Smith building on North Campus were also complete this year, offering clients resources and support in a fresh, modern setting.

The Center was also successful in achieving accreditation from the National Committee for Quality Assurance (NCQA), a goal set by our team in FY22. September 1 st (FY24) marked another milestone in the Spindletop Center historical timeline as Jasper County was added as part of our catchment area. Months of diligent work in FY23 led up to this transition and much is still being done to effectively transition these services from Burke Center to Spindletop Center. It's an honor and privilege to be serving more individuals through this opportunity. The Hope Center, our Peer Recovery program, hosted its inaugural Gala, raising awareness of our services and much needed funds for the center.

Additionally, Spindletop Center was able to add important and meaningful programs for the community thanks to our generous community funders and supporters. In total, \$3,507,533 in grant funding was received for Spindletop Center programs such as mental health and financial assistance to veterans, social enrichment for individuals with intellectual and developmental disabilities, a sensory room for our individuals with IDD, substance use disorder treatment funding, a three year Licensed Professional Counselor Associate program, mental health for law enforcement officers training, transportation assistance, two Multi-Systemic Teams, and enrichment supplies for the child mental health program to name a few.



Our 2024 outlook is strong. We will continue to fine tune the Jasper County service area with plans to co-locate services within an existing pediatric clinic to provide youth mental health services, add IDD services and potential mental health deputy expansion to our Jasper County community.

What we do takes a team. Serving five counties, 81 cities, more than 16,000 clients through 29 programs takes us all striving every day to improve lives and give hope to people and families in our community who are living with mental health, substance use and IDD conditions. I continue to be amazed at the more than 500 employees who show their collective dedication and commitment to our communities, and as we continue to expand and provide services in more broad scope, they continue to rise to the challenge.

Where I see compassion and care, I admire their tenacity and strength exhibited by willingness to work through every obstacle to ensure our clients receive the best possible support. It's an honor to witness our team stand as advocates, lend empathy to families in challenging times, break barriers and forge ahead on behalf of clients or simply be a listening ear. For it's in the moments, big and small, we are making the most impact. Our history is rich, legacy is long and commitment is deep. Together this year, we'll celebrate nearly 60 years of our dedication to helping those we serve achieve the highest possible level of independence and success – making a difference. Every day.




